"TSA Behavioral Analysts Are Only Slightly Better Chance" says the Government Accounting Office

The Transportation Security Administration has spent \$900 million since 2007 to train 3000 **behavior detection officers** at airports nationwide. "The ability of humans to accurately identify deception based on behaviors is the same, roughly - essentially the same as chance - slightly greater than chance - 54%," Stephen Lord, director of the Office of Homeland Security, said in testimony on November 23, 2013 before a House subcommittee.



TSA's Ability to Detect Bombs

TSA conducted a study to determine their agents ability to detect bomb paraphernalia.

- Agents at Los Angeles International failed to identify 75% of bomb components.
- Chicago O'Hare missed 60% of bomb components.
- San Francisco, run by private security, missed 20%.
- At Dallas Ft. Worth International an operator of a body scanner missed a gun strapped to an undercover TSA agent's leg.

Senior Saudi prince injured in suicide bombing

RIYADH, Saudi Arabia - A suicide bomber lightly wounded a senior prince largely credited for Saudi Arabia's anti-terrorism campaign when he blew himself up just before going into a gathering of well-wishers for the Muslim holy month of Ramadan, the state news agency said Friday.



It was the first known assassination attempt against a member of the royal family since Saudi Arabia began its crackdown on al-Qaida affiliated militants eight years ago following the Sept. 11 terror attacks in the United States.

Bosom bombers: Women have explosive breast implants

LONDON – Agents for Britain's MI5 intelligence service have discovered that Muslim doctors trained at some of Britain's leading teaching hospitals have returned to their own countries to fit surgical implants filled with explosives, according to a report from Joseph Farah.

Women suicide bombers recruited by al-Qaida are known to have had the explosives inserted in their breasts under techniques similar to breast enhancing surgery. The lethal explosives – usually PETN (pentaerythritol Tetrabitrate) – are inserted during the operation inside the plastic shapes. The breast is then sewn up.

Similar surgery has been performed on male suicide bombers. In their cases, the explosives are inserted in the appendix area or in a buttock. Both are parts of the body that diabetics use to inject themselves with their prescribed drugs.

Explosive experts at Britain's Porton Down biological and chemical warfare research center told MI5 that a sachet containing as little as five ounces of PETN when activated would blow "a considerable hole" in an airline's skin which would guarantee it would crash.

Dubai police chief warns of "international plot" against Gulf states, says Iran, Syria and MB must know Gulf is a red line.



DUBAI - Dubai's chief of police has warned of an "international plot" to overthrow the governments of Gulf Arab countries, saying the region needs to be prepared to counter any threat from Islamist dissidents.

"There's an international plot against Gulf states in particular and Arab countries in general... This is preplanned to take over our fortunes," Khalfan told reporters at a gathering late on Wednesday marking the Muslim holy month of Ramadan.

"The bigger our sovereign wealth funds and the more money we put in the banks of Western countries, the bigger the plot to take over our countries... The brothers and their governments in Damascus and North Africa have to know that the Gulf is a red line, not only for Iran but also for the Brothers as well."

"I had no idea that there is this large number of Muslim Brotherhood in the Gulf states. We have to be alert and on guard because the wider these groups become, the higher probability there is for trouble," Khalfan said on Wednesday.

"We are aware that there are groups plotting to overthrow Gulf governments in the long term."

UAE: Gulf must tackle Muslim Brotherhood threat

United Arab Emirates FM Sheikh Abdullah cautions Brotherhood threatening state sovereignty, urges cooperation against Islamists.

ABU DHABI - Gulf Arab countries should work together to stop Islamist group the Muslim Brotherhood plotting to undermine governments in the region, the United Arab Emirates' foreign minister said on Monday.

The UAE, a major oil exporter and business hub, has arrested around 60 local Islamists this year, accusing them of belonging to the Muslim Brotherhood - which is banned in the country - and conspiring to overthrow the government.

Last month, local media reported that some of those detained had confessed that their organization was running an armed wing and had been plotting to take power and establish an Islamist state. Al-Islah has since denied this.

The reports also said the group was coordinating with Brotherhood organizations in three other Gulf Arab countries, and that they had recently received up to 10 million dirhams (\$3.67 million) from a counterpart in another Gulf Arab country.

Al Islah says it shares a similar ideology with the Muslim Brotherhood in Egypt but has no direct links and is pushing for only peaceful reforms.

Dubai's outspoken police chief Dhahi Khalfan said in March there was an "international plot" against Gulf states by the Muslim Brotherhood organization.



(57) ABSTRACT

The Psychophysiological Touch Screen Stress Analyzer is capable of capturing information on how a person emotionally reacts to a series of verbal, visual, or written stimulus when the person touches the touch screen computer monitor in response to the stimulus.

A group of Ph.D. forensic psychologists recently conducted an evaluation of the PTSSA System's ability to determine its reliability in determining when a subject is being truthful or less than truthful. All subjects in this study were in an alcohol/drug treatment program and must submit to frequent urine analysis.

Question 12: Do you believe you will test positive for alcohol?

Question 16: Do you believe you will test positive for illegal drugs?

The PTSSA System analysis of questions concerning the alcohol and drug program showed 92% accuracy after testing 77 subjects. A scientific paper was published in the International Journal of Clinical Psychiatry and Mental Health, 2014, 2, 70-76 with these results.

A second study was published of another 101 subjects showed a 92% accuracy.

Adjustments were made to the PTSSA algorithm and achieved an accuracy of 97%.

The PTSSA system was successfully tested in a real-world environment for 15 days in December 2010 at Nigeria's Murtala Muhammed International Airport in Lagos. More than 1,500 passengers were randomly selected and screened.

The PTSSA system identified 75 individuals involved in smuggling activities – by their own admissions – and 6 individuals involved in terrorist activities, by their emotional reaction indicators.

This testing process was monitored and observed by officials from the Nigerian Civil Aviation Agency (NCAA) and the Federal Aviation Administration of Nigeria (FAAN).
